**Course Description**

This course introduces and explores the legal and theoretical issues surrounding the domestic relations of adults. Topics include, among others, the regulation of marriage eligibility, the legal treatment of spouses in an ongoing marriage, intimate nonmarital relationships, the constitutional right to privacy and procreation, domestic violence, divorce, and child custody and support. This course will also explore issues that emerge in the practice of family law.

The material in this course is drawn from traditional legal sources such as case law, statutes, and model rules. At times, the course may also include material generally drawn from social and behavioral sciences. Family law is a complex area of the law that overlaps with several other legal areas such as constitutional law, contract, and tort. Students are encouraged to identify and consider these complexities as they examine, and develop familiarity with, the course material.
